WIIT is Euronext Tech Leader

Euronext Tech Leaders consists of 108 selected technology companies listed on one of the seven exchanges operated by Euronext, with a combined market capitalization of one trillion euros. Among other things, the new segment serves to demonstrate the strength of the European technology industry. Prior to this, the company had acquired the cloud, hosting and DevOps specialists myLoc managed IT, MIVITEC, Boreus and GECKO in Germany and integrated them into the corporate group. WIIT now employs more than 300 people in Germany at five locations in Düsseldorf, Munich, Stralsund, Rostock and Berlin.
